Chatham County Superior Court Clerk's office in conjunction with the Georgia Superior Court Clerks' Cooperative Authority (GSCCCA) is pleased to offer the Filing Activity Notification System, FANS, providing Georgia citizens with tools to monitor activity regarding their property and records.

FANS is a free, voluntary, opt-in program that can be used to send electronic notifications of filing activity to individuals who create notifications in the system. The notifications generated by this system are not guaranteed to be accurate or complete, and use of the system is subject to an acknowledgement of these conditions.

To get started, go to <u>https://fans.gsccca.org</u> and follow the prompts. Users will have to renew their registration annually. The service does not automatically renew. The registration is only good for one year from the registration date.

We hope you find this service to be beneficial as Chatham County Superior Court Clerk's office continues to explore and implement new ways to improve services delivered to the citizens of Chatham County.

The Filing Activity Notification System (FANS) was designed to offer individuals the ability to receive a notification when certain real estate and personal property records are filed with, indexed, and data is transmitted by Clerks of Superior Court throughout the state of Georgia.



WHEN?

With official approval of the Authority's Board of Directors during the July 2022 board meeting, Authority staff moved forward with development of FANS. The Authority staff set an aggressive development timeline in order to make FANS available in January 2024. Development was completed, exhaustively tested and published on January 15, 2024.

F.A.N.S. will also notify of filing activity related to personal property, liens and plat filings. "With our Clerk of Superior Court partners, we are excited to roll out F.A.N.S. We believe the Filing Activity Notification System gives the property owner tools to monitor filing activity which could help prevent property fraud," stated John Earle, GSCCCA Executive Director.

Citizens can simply register here <u>https://fans.gsccca.org/</u> with an email address or telephone number. After submitting a name, the user will receive an email and/or text notification whenever a filing related to that name is filed in the selected records.

The Georgia Superior Court Clerks' Cooperative Authority was created by an act of the Georgia General Assembly in 1993. The purpose of the GSCCCA is to provide a cooperative for the development, acquisition, and distribution of record management systems, information, services, supplies, and materials for Superior Court Clerks and Georgia's citizens, while providing cost savings to local government and the state of Georgia.

Welcome to the Filing Activity Notification System

The Filing Activity Notification System (FANS) is designed to offer individuals the ability to receive a notification when certain real estate and personal property records are filed with, indexed, and data is transmitted by Clerks of Superior Court throughout the state of Georgia.

Individuals may opt-in to this voluntary system designed to send an electronic notification of the filing and of a document in select official county records when document index data entered and transmitted to the Georgia Superior Court Clerks' Cooperative Authority by the Clerk matches the notification criteria you set. All notifications will only be forward-looking and generated for a document filed and index data received after the date the user creates a notification request.

All user notifications generated by the system are entirely dependent upon index data entered and transmitted by the Clerk of Superior Court in the county of filing. As a result, any notices generated by this system are not guaranteed by the Georgia Superior Court Clerks' Cooperative Authority to be either comprehensive, accurate, complete, or current. The user of the system acknowledges these conditions as well as additional conditions and restrictions related to the type of notifications the user may define and the general terms and conditions of this website.



Notification Request Types

- Name Notification, Address Notification and Document Notification.
- At least one Name Notification must be active for the other notification types to be enabled.
- When creating or editing notifications, you must acknowledge additional conditions each time.



Notification Request Types

Name Notification Request

- First Name uses a starts-with match-type which searches for first name records beginning with the specified characters.
- Last Name uses an exact match-type which searches for last name records containing ONLY the specified characters entered.
- Can monitor all Georgia counties or a specific county.
- Monitors the Real Estate, Lien, Plat, Transfer Tax Declarations (PT-61) and Uniform Commercial Code (UCC) indexes.

Notification Request Types

Address Notification Request

- Only monitors for addresses in either filed Transfer Tax (PT-61) declaration data or Uniform Commercial Code (UCC) data.
 - ★ Why? This is the only data the GSCCCA received with Address information.
- Can monitor all Georgia counties or a specific county.

Document Notification Request

- Document notifications will only be generated for Real Estate, Lien, and Plat requests when the book and page reference found in an applicable document has been indexed by the Clerk of Superior Court and transmitted to the GSCCCA.
- Document notifications will only be generated for Uniform Commercial Code (UCC) requests when the file number in an applicable document has been indexed.
- Must specify the County in addition to the Book and Page or UCC File Number.


