- 2. On the date referenced on my attached Affidavit, I received the identity and address of all known owners of such vehicle from the local law enforcement agency for the jurisdiction in which my business is located as evidenced by said Affidavit and document(s) attached hereto and incorporated herein as "Exhibit B"; and,
- 3. Using the information contained in Exhibit B, through certified or registered mail or statutory overnight delivery, within seven (7) calendar days of the day such motor vehicle was removed or one (1) business day after the information was furnished to the remover or storage, whichever is later, I notified or attempted to notify by written acknowledgement signed thereby or by certified or registered mail or statutory overnight delivery, the owner, lessor, lessee, or any holder of a lien or security interest of said vehicle that said vehicle would be deemed abandoned at the expiration of thirty (30) days of the date such vehicle was removed as evidenced by the documents attached hereto and incorporated herein as "Exhibit C"; and,
- 4. Within seven (7) calendar days of the date the vehicle was deemed abandoned in accordance with O.C.G.A. § 40-11-2(d), without said vehicle having been redeemed, I gave notice in writing to the Department of Revenue or applicable County Tag Agent (hereinafter referred to as the "Department") pursuant to the procedure set forth in O.C.G.A. § 40-11-2(e) and requested the name and address of all owners of such vehicle and/or I had knowledge of facts that would reasonably indicate that the vehicle was registered or titled in another state, therefore, I checked the motor vehicle records of that other state in the attempt to ascertain the identity of the owner as prescribed by O.C.G.A. § 40-11-2(e) and as evidenced by the document(s) attached hereto and incorporated herein as "Exhibit D"; and,
- 5. On the date referenced on my attached Affidavit, I received the names of all owners of such vehicle as evidenced by said Affidavit and document(s) attached hereto and incorporated herein as "Exhibit E"; and,
- 6. Within five (5) calendar days of having received the information requested in Exhibit E, I either (check which was completed):
 - a. Notified the owner, any lessee and any holder of lien or security interest of the location of the vehicle and the fact that the vehicle is deemed abandoned and will be disposed of if not redeemed by certified or registered mail or statutory overnight delivery as evidenced by the document(s) attached hereto and incorporated herein as "Exhibit F"; or,
 - b. Placed an advertisement in a newspaper of general circulation in the county where such vehicle was obtained once a week for two (2) consecutive weeks as evidenced by my attached Affidavit or Affidavit of the newspaper incorporated herein as "Exhibit F" because the identity of the owner could not be ascertained; or,
