Standing Order Establishing Juvenile Treatment Court Division and Creation of Specialized Court to Address Children Identified as Humans Involved with the Commercial Sexual Exploitation of Children (CSEC) and Labor Trafficked Youth

This Standing Order hereby establishes a Juvenile Treatment Court Division in the Chatham County Juvenile Court and extends the established specialized Court to address children identified as humans involved with Commercial Sexual Exploitation (CSEC) and Labor Trafficked Youth (LTY), which was established by the Chatham County Juvenile Court on August 2, 2020, and further designates it as a Juvenile Treatment Court pursuant to O.C.G.A.§15-11-71. This Court was/is named Healing Opportunities Through Positive Empowerment Court (H.O.P.E. Court).

This Court is a trauma informed treatment Court with a multi-disciplinary team of professionals to develop best practices, protocols in identifying CSEC and LTY youth, and the identification and development of appropriate services.

STANDING ORDER ESTABLISHING A JUVENILE TREATMENT COURT DIVISION AND REAUTHORIZING SPECIALIZED COURT

TO ADDRESS CHILDREN IDENTIFIED AS HUMANS INVOLVED WITH THE COMMERCIAL SEXUAL EXPLOITATION OF CHILDREN

(CSEC) AND LABOR TRAFFICKED YOUTH

House Bill 873 amended Title 15 of the Official Code of Georgia Annotated defining

accountability courts in Georgia. The revision provides that "accountability court' means

a superior, state, or juvenile court that has a drug court division, mental health court

division, veterans court division, juvenile treatment court division, or operating under the

influence of court division, or a juvenile court that has a family treatment court division."

O.C.G.A.§15-1-18. It also authorized the Juvenile Court to establish a Juvenile Treatment

Court division. O.C.G.A.§15-11-71. H.O.P.E. Court would be categorized as an

accountability court under the Juvenile Treatment Court division. O.C.G.A.§15-1-18 and

71.

The Juvenile Court may establish a juvenile treatment court division to provide an

alternative to the traditional judicial system for the disposition of juvenile delinquency and

CHINS cases. O.C.G.A. §15-11-71(a)(3). This Court has already completed the planning and

work plan requirements of O.C.G.A.§15-11-71(a)(5).

The juvenile court has exclusive jurisdiction concerning a child who is alleged to be a

delinquent, a child in need of services, or a dependent child. O.C.G.A. §15-11-10. Over the

years this Court has identified a growing and disturbing number of CSEC and LTY involved

youth. Acts of delinquency or Child in Need of Services (CHINS) may be a result of

victimization rather than status offenses or delinquent behavior.

STANDING ORDER ESTABLISHING A JUVENILE TREATMENT COURT DIVISION AND REAUTHORIZING SPECIALIZED COURT TO ADDRESS CHILDREN IDENTIFIED AS HUMANS INVOLVED WITH THE COMMERCIAL SEXUAL EXPLOITATION OF CHILDREN (CSEC) AND LABOR TRAFFICKED YOUTH

This Court requires the use of a trauma-informed court with a multi-disciplinary team of professionals to develop and implement best practices, protocols in identifying CSEC and LTY youth, and the identification and development of appropriate services.

Effective September 1, 2024, the Superior Court of Chatham County re-appointed the Honorable Roxanne E. Formey to a four-year appointment as a judge of the Juvenile Court of Chatham County. Judge Formey is committed to impartially, competently, and diligently presiding over a CSEC/LTY specialized court in matters that this court has exclusive or concurrent jurisdiction.

IT IS HEREBY ORDERED that a CSEC/LTY specialized court be reestablished as a juvenile treatment court pursuant to O.C.G.A. §15-11-71, under the direction of the Honorable Roxanne E. Formey or such other judge subsequently designated.

The Clerk of the Juvenile Court is directed to place this administrative order in the minutes of this Court.
