## **Superior Court Oversight of Juvenile Court**

The Superior Court has oversight, control and supervisory responsibility over Juvenile Court. OCGA § § 15-6-8(4), 15-11-50, 15-11-54(a). This protocol establishes the responsibility and leadership roles of the judges and court administrators of both courts.

## **Presiding Juvenile Court Judge**

- The Superior Court Chief Judge is empowered to remove and appoint a new Juvenile Court Presiding Judge after advice and counsel from the other Superior Court judges.
- Superior Court Chief Judge conducts a formal confidential evaluation process for the Juvenile Court Presiding Judge on a periodic, recurring basis as he or she determines.
- Policy development and decision making will be made by consensus among all judges of the Juvenile Court.
- When consensus cannot be reached, the Presiding Judge of Juvenile Court shall have the
  responsibility for making any decisions that affect the Juvenile Court as a whole,
  provided that the decision does not unduly interfere with the autonomy of each
  Juvenile Court Judge's processes regarding the conduct of matters in their courtroom.

## **Juvenile Court Administrator**

- Juvenile Court Administrator shall be hired and removed by the Superior Court Administrator, with consultation and input from the Presiding Juvenile Court Judge and other Juvenile Court Judges.
- Juvenile Court Administrator is appointed and serves at the pleasure of the Superior Court Administrator.
- Juvenile Court Administrator reports to the Superior Court Administrator but engages primarily with the Presiding Judge of Juvenile Court and the other Juvenile Court Judges.
- Juvenile Court Administrator has management oversight of all non-judicial court administrative staff at the Juvenile Court and manages the day-to-day affairs of the Court under the direction of the Presiding Judge and the Juvenile Court Judges.
- The Superior Court Administrator may from time to time prescribe additional management duties of the Juvenile Court Administrator.
- An annual performance evaluation shall be completed by the Superior Court
   Administrator of the Juvenile Court Administrator, with input from the Juvenile Court
   Judges and appropriate administrative staff.
