STANDING ORDER

The Judges of the Superior Court of the Eastern Judicial Circuit have determined that the business of the Court requires the temporary assistance of an additional judge or additional judges. It has further been determined that such need is for calendar year 2025, that such temporary assistance is needed from time to time, and that need for such temporary assistance is occasionally required on short notice.

Therefore, pursuant to O.C.G.A. § 15-1-9.1(b)(2), the Chief Judge of the Superior Court of the Eastern Judicial Circuit hereby makes written request for temporary assistance as needed to the Presiding Judge of the Juvenile Court of Chatham County for the following judges: Honorable Thomas L. Cole, Honorable Roxanne E. Formey, Honorable Lindretta Grindle Kramer and Honorable Laura Singleton to preside as requested.

It is acknowledged that the designated judge is qualified to serve as judge in the requesting court. It is further acknowledged that the assisting judge shall discharge all the duties and shall exercise all of the powers and authority of a Judge of the Superior Court. It is further agreed and acknowledged that the requesting court shall supply to

the assisting judge courtroom facilities and support personnel of the office of the Clerk and of the Sheriff's Department and that the assisting judge shall supply his/her judicial administrative assistant and law clerk.

This Order, containing a standing written request by the Superior Court of the Eastern Judicial Circuit for temporary assistance and a written designation of assisting judges, shall be filed and recorded on the minutes of the Clerk of Superior Court and shall remain in effect for the period of January 1, 2025 to December 31, 2025.
