Sealed proposals will be received at the Office of the Purchasing Agent, **1117 EISENHOWER DRIVE, SUITE C, SAVANNAH, GEORGIA** up to <u>5:00 P.M.</u> <u>April 15, 2014</u>. The Purchasing Agent reserves the right to reject any and all proposals and to waive formalities.

Instructions for preparation and submission of a proposal are contained in the Request for Proposal package. Please note that specific forms for submission of a proposal are required. Proposals must be typed or printed in ink. If you do not submit a proposal, return the signed invitation sheet and state the reason; otherwise, your name may be removed from our bidders list.

A pre-proposal conference has been scheduled for <u>10:00 A.M.</u>, <u>April 1, 2014</u>, and will be conducted in the 3<sup>rd</sup> Floor Conference Room, located in **SUITE 350, 124 BULL STREET**, Savannah, Georgia, to discuss the specifications and resolve any questions and/or misunderstanding that may arise.

Any changes to the conditions and specifications must be in the form of a written addendum to be valid; therefore, the Purchasing Agent will issue a written addendum to document approved changes. Generally when addenda are required, the bid opening date will be changed.

Chatham County has an equal opportunity procurement policy. Chatham County seeks to ensure that all segments of the business community have access to providing services needed by County programs. The County affirmatively works to encourage utilization of disadvantaged and minority business enterprises in our procurement activities. The County provides equal opportunity for all businesses and does not discriminate against any persons or businesses regardless of race, color, religion, age, sex, national origin or handicap. The County expects its contractors to make maximum feasible use of minority businesses and qualified minority employees. The terms "disadvantaged business", "minority business enterprise", and "minority person" are more specifically defined and explained in the <u>Chatham County Purchasing</u> <u>Ordinance and Procedures Manual</u>, Article VII - Disadvantaged Business Enterprises Program.

#### SECTION I INSTRUCTIONS TO PROPOSERS

**1.1 PURPOSE:** The purpose of this document is to provide general and specific information for use in submitting a proposal to supply Chatham County with services as described herein. All proposals are governed by the <u>Code of Chatham County</u>, Chapter 4, Article IV, and the laws of the State of Georgia.

**1.2 HOW TO PREPARE PROPOSALS:** All proposals shall be typewritten and signed by the business owner or authorized representative, with all corrections initialed and dated by the official signing the proposal. *ALL SIGNATURE SPACES MUST BE SIGNED*.

Proposers are encouraged to review carefully all provisions and attachments of this document prior to submission. Each proposal constitutes an offer and may not be withdrawn except as provided herein.

#### 1.3 HOW TO SUBMIT PROPOSALS: All proposals shall be:

- A. Submitted in sealed opaque envelopes, plainly marked with the proposal number and title, date and time for submission, and company name.
- B. Mailed or delivered as follows in sufficient time to ensure receipt by the Purchasing Agent on or before the time and date specified above.

## Chatham County will not accept telegraphic or electronically transmitted proposals.

#### PROPOSALS NOT RECEIVED BY THE TIME AND DATE SPECIFIED WILL NOT BE OPENED OR CONSIDERED.

- **1.4 HOW TO SUBMIT AN OBJECTION:** Objections from Offers to this Request for Proposals and/or these specifications should be brought to the attention of the County Purchasing Agent in the following manner:
  - A. When a pre-proposal conference is not scheduled, the Proposer shall object in writing not less than five (5) days prior to the Date for submission (note: a pre-proposal conference has been scheduled)
  - B. The objections contemplated must pertain both to form and substance of the Request for Proposal documents. Failure to object in accordance with the above procedure will constitute a waiver on the part of the business to protest this Request for Proposal.
  - C. The objections contemplated may pertain either or both to form and substance of the Request for Proposal documents. Failure to object in accordance with the above procedure will constitute a waiver on the part of the business to protect this Request for Proposal.
- **1.5 FAILURE TO OFFER:** If a Proposal is not submitted, the business should return this Request for Proposal, stating reason therefore, and indicate whether the business should be retained or removed from the County's bidders list.
- **1.6 ERRORS IN PROPOSALS:** Proposers or their authorized representatives are expected to fully inform themselves as to the conditions, requirements, and specifications before submitting proposals. Failure to do so will be at the Proposer's own risk.

- **1.7 STANDARDS FOR ACCEPTANCE OF PROPOSERS FOR CONTRACT AWARD:** The County reserves the right to reject any or all Proposals and to waive any irregularities or technicalities in Proposals received whenever such rejection or waiver is in the best interest of the County. The County reserves the right to reject the Offer of a Proposer who has previously failed to perform properly or complete on time contracts of a similar nature, whom investigation shows is not in a position to perform the contract.
- **1.8 PROPOSER:** Whenever the term "Proposer" is used it shall encompass the "person", "business", "firm", or other party submitting a proposal to Chatham County in such capacity before a contract has been entered into between such party and the County.
- **1.9 COMPLIANCE WITH LAWS:** The Proposer shall obtain and maintain all licenses, permits, liability insurance, workman's compensation insurance and comply with any and all other standards or regulations required by federal, state or County statute, ordinances and rules during the performance of any contract between the Proposer and the County. Any such requirement specifically set forth in any contract document between the Proposer and the County shall be supplementary to this section and not in substitution thereof.
- **1.10 CONTRACTOR:** Contractor or subcontractor means any person, firm, or business having a contract with Chatham County. The Contractor of goods, material, equipment or services certifies that the firm will follow equal employment opportunity practices in connection with the awarded contract as more fully specified in the contract documents.
- 1.11 LOCAL PREFERENCE: The contractor agrees to follow the local preference guidelines as specified in the contract documents, which state "The CONTRACTOR hereby agrees, as part of the consideration to Chatham County for making this Contract, that the CONTRACTOR in the carrying out of this contract will give the citizens of Chatham County preference for employment to perform all labor required by this contract; that the rate of wages to be paid shall not be less than legally required; and that in the purchase of materials to be used in the Work of the Project, preference shall be given to sources from within Chatham County to the maximum extent possible. The CONTRACTOR will cause the forgoing provisions to be inserted in all subcontracts so that provisions will be binding upon each subcontractor."

#### SECTION II GENERAL CONDITIONS

- 2.1 SPECIFICATIONS: Any obvious error or omission in specifications shall not inure to the benefit of the bidder but shall put the Proposer on notice to inquire of or identify the same to the County.
- 2.2 **MULTIPLE PROPOSALS:** No Proposer will be allowed to submit more than one offer. Any alternate proposals must be brought to the Purchasing Agent's attention during the Pre-proposal Conference or submitted in writing at least five (5) days preceding the date for submission of proposals.
- **2.3 OFFERS TO BE FIRM:** The Proposer warrants that terms and conditions quoted in his offer will be firm for acceptance for a period of sixty (60) days from bid date submitted,

unless otherwise stated in the proposal. When requested to provide a fee proposal, fees quoted must also be firm for a sixty day period.

- **2.4 COMPLETENESS:** All information required by the Request for Proposals must be completed and submitted to constitute a proper proposal.
- **2.5 LAWSUITS, BRIBERY:** Prospective proposers shall disclose any record of pending lawsuits, criminal violations and/or convictions, etc., and shall not have conflicts of interest.
- 2.6 LIABILITY PROVISIONS: Where Proposers are required to enter or go into Chatham County property to take measurements or gather other information in order to prepare the proposal as requested by the County, the Proposer shall be liable for any injury, damage or loss occasioned by negligence of the Proposer, his agent, or any person the Proposer has designated to prepare the Offer and shall indemnify and hold harmless Chatham County from any liability arising therefrom. The contract document specifies the liability provisions required of the successful Proposer in order to be awarded a contract with Chatham County.
- **2.7 CERTIFICATION OF INDEPENDENT PRICE DETERMINATION:** By submission of this Offer, the Proposer certifies, and in the case of a joint offer each party thereto certifies as to its own organization, that in connection with this procurement:
  - (1) The prices in this offer have been arrived at independently, without consultation, communication, or agreement, for the purpose of restricting competition, as to any matter relating to such prices with any other competitor;
  - (2) Unless otherwise required by law, the prices which have been quoted in this offer have not been knowingly disclosed by the Proposer and will not knowingly be disclosed by the Proposer prior to opening, directly or indirectly to any other competitor; and
  - (3) No attempt has been made or will be made by the Proposer to induce any other person or firm to submit or not submit an offer for the purpose of restricting competition.
- **2.8 AWARD OF CONTRACT:** The contract, if awarded, will be awarded to that responsible Proposer whose proposal will be most advantageous to Chatham County, all factors considered. The Board of Commissioners will make the determination as to which proposal best serves the interest of Chatham County.
- **2.9 TERM OF CONTRACT:** The initial term of the contract will be for one (1) year with the option to renew for four (4) additional years. Fee proposals will be requested for all five (5) years.
- 2.10 PERFORMANCE AND APPROVAL OF SUB-CONSULTANTS: The proponent will perform the project as an independent contractor and not as an agent or employee of the County. Joint ventures and sub-consultant arrangements are not prohibited; however, the proponent shall secure written permission from Chatham County before subcontracting any part of this service. Such permission should be obtained during the proposal evaluation stage.

Proponents are encouraged to use Local, Minority and Women Owned Businesses where feasible in providing these services.

#### 2.11 AWARD AND CONTRACT

- 2.11.1 A Copy of a County Contract is on file in the Office of Purchasing and Contracting. Proposals will become part of the contract by reference and incorporated therein.
- 2.11.2 No work shall be performed under the contract until a contract has been fully executed by both parties. A notice to proceed will be issued by Chatham County.
- 2.12 CHANGES: In the event a contract is awarded, the County may, at any time during the contract period, make changes within the general scope of the contract and its technical provisions. If any such change causes any increase or decrease in the proponent's cost of performing any part of the contract, whether changed or not changed by any such notice, an equitable adjustment shall be made in the contract prices, or in the time of performance, or in both. A written memorandum of such adjustment shall be made.

Any claim by the proponent for an equitable adjustment shall be supported by detailed cost and pricing data, which the County shall have the right to verify by audit of the proponent's records or, at the County's election, by other appropriate means. Any claim by the proponent for an equitable adjustment shall be made in writing and prior to proceeding with the additional services or capital investments. The County may accept and act upon claims made later if, in the County's sole discretion, circumstances justify so doing. Nothing in this clause shall excuse the proponent from proceeding with performance of this contract in accordance with its original terms and conditions and any approved changes.

- 2.13 **TERMINATION OF CONTRACT:** The County shall have the right to terminate any contract to be made hereunder for its convenience by giving the proponent written notice 30 days in advance of its election to do so and by specifying the effective date of such termination. The proponent shall be paid for services rendered and not in question or dispute through the effective date of such termination. Further, provided a contract is awarded, if a proponent shall fail to fulfill any of its obligations hereunder, the County may, by giving written notice to the proponent at issue, terminate the agreement with said proponent for such default. If this agreement is so terminated, the proponent shall be paid only for work satisfactorily completed.
  - **2.14 ASSIGNMENT:** The Contractor shall not assign or transfer any interest of the contract without prior written consent of the County.
  - 2.15 **PROCUREMENT PROTESTS:** Objections and protests to any portion of the procurement process or actions of the County staff may be filed with the Purchasing Agent for review and resolution. The <u>Chatham County Purchasing Procedures Manual</u>, Article IX Appeals and Remedies shall govern the review and resolution of all protests.
  - 2.16 QUALIFICATION OF BUSINESS RESPONSIBLE PROPOSER: A responsible Proposer is defined as one who meets, or by the date of the acceptance can meet, all requirements for licensing, insurance, and service contained within this Request for Proposals. Chatham County has the right to require any or all Proposers to submit documentation of the ability to perform the service requested. Chatham County has the right to disqualify the proposal of any Proposer as being unresponsive whenever such Proposer cannot document the ability to deliver the requested service.

- 2.17 COUNTY BUSINESS LICENSE REQUIREMENT: A current Chatham County or municipal business license (within the State of Georgia) is required unless otherwise specified. A firm need not have a Chatham County Business License prior to submitting a proposal. However, a license must be obtained by the successful vendor prior to award of contract. Please contact the Chatham County Department of Building Safety and Regulatory Services at (912) 201-4300 for additional information. No contract shall be awarded unless all real and personal property taxes have been paid by the successful contractor and/or subcontractors (reference action of Chatham County Board of Commissioners, April 8, 1994).
- 2.18 LICENSES, PERMITS, TAXES: The price or prices for the service shall include full compensation for all fees that the proponents or may be required to pay. Chatham County Tax Exempt. A Tax Exemption Certificate will be provided by the Purchasing & Contracting Office upon request (912-790-1618 or 912-790-1627).
- 2.19 **INSURANCE PROVISIONS:** The selected CONTRACTOR shall be required to procure and maintain for the duration of the contract insurance against claims and injuries to persons or damage to property which may arise from or in connection with the performance of work hereunder by the Contractor, his agents, representatives, employees, or subcontractors. The cost of such insurance shall be included in the Contractor's fee proposal.

Chatham County evaluates each claim on a case-by-case basis and invokes all immunities and defenses permitted under law. Chatham County is *not* to be included as a named insured on Contractor's policies.

A certificate of insurance regarding this Request for Proposal shall include the following:

- A. Worker's Compensation: Statutory, with a minimum Employer's Liability limit of \$500,000.
- *B. Commercial General Liability:* \$1,000,000 bodily injury and property damage per occurrence and annual aggregate.
  - *C. Business Automobile:* \$1,000,000 Combined Single limit written on an "Any Auto" basis.
  - *D. Fidelity Bond/Professional Liability:* \$3,000,000 Covers lost due to crime or dishonesty by employee of/or the CONTRACTOR.
- 2.20 INDEMNIFICATION: The CONTRACTOR agrees to protect, defend, indemnify, and hold harmless Chatham County, Georgia, its commissioners, officers, agents, and employees from and against any and all liability, damages, claims, suits, liens, and judgments, of whatever nature, including claims for contribution and/or indemnification, for injuries to or death of any person or persons, or damage to the property or other rights of any person or persons caused by the CONTRACTOR or its subcontractors. The CONTRACTOR's obligation to protect, defend, indemnify, and hold harmless, as set forth herein above shall include, but not be limited to, any matter arising out of any actual or alleged infringement of any patent, trademark, copyright, or service mark, or any actual or alleged unfair competition, disparagement of product or service, or other business tort of any type whatsoever, or any actual or alleged violation of trade regulations. CONTRACTOR

further agrees to investigate, handle, respond to, provide defense for, and to protect, defend, indemnify, and hold harmless Chatham County, Georgia, at his sole expense, and agrees to bear all other costs and expenses related thereto, even if such claims, suits, etc., are groundless, false, or fraudulent, including any and all claims or liability for compensation under the Worker's Compensation Act arising out of injuries sustained by any employee of the CONTRACTOR or his subcontractors or anyone directly or indirectly employed by any of them. The CONTRACTOR'S obligation to indemnify Chatham County under this Section shall not be limited in any way by the agreed-upon contract price, or to the scope and amount of coverage provided by any insurance maintained by the CONTRACTOR.

- 2.21 COMPLIANCE WITH SPECIFICATION TERMS AND CONDITIONS: The Request for Proposals, Legal Advertisement, General Conditions and Instructions to Proposers, Specifications, Special Conditions, Proposers Offer, Addendum, and/or any other pertinent documents form a part of the Offer's proposal and by reference are made a part of a resulting contract.
- 2.22 SIGNED RESPONSE CONSIDERED AN OFFER: The signed Response shall be considered an offer on the part of the Proposer, which offer shall be deemed accepted upon approval by the Chatham County Board of Commissioners, Purchasing Agent or his designee. In case of a default on the part of the Proponent after such acceptance, Chatham County may take such action as it deems appropriate, including legal action for damages or lack of required performance.
- 2.23 NOTICE TO PROCEED: The successful proposer shall not commence work under this Request for Proposal until a written contract is awarded and a Notice to Proceed is issued by the Purchasing Agent or his designee. If the successful Proposer does commence any work or deliver items prior to receiving official notification, he does so at his own risk.
- 2.24 LITIGATION VENUE: The parties waive the privilege of venue and agree that all litigation between them in the state courts shall take place in Chatham County, Georgia and that all litigation between them in the federal courts shall take place in the United States District Court in Chatham County, State of Georgia.
- 2.25 **PENDING LITIGATION:** Proposals will not be accepted from any company, firm, person, or party, parent subsidiary, against which Chatham County has an outstanding claim, or a financial dispute relating to prior contract performance. **CONTRACT:** The successful respondent will be expected to execute a contract within 10 days of notice to award. Upon award of the contract, the proponent shall be bound to deliver services on the terms and conditions of this document and any negotiations which may occur.
- **2.26 REJECTING PROPOSALS:** The County reserves the right to reject any or all proposals and is not bound to accept any proposal if that proposal is contrary to the best interest of the Chatham County.
- 2.27 COST TO PREPARE RESPONSES: The County assumes no responsibility or obligation to the respondents and will make no payment for any costs associated with the preparation or submission of the proposal.

**2.28 EQUAL EMPLOYMENT OPPORTUNITY:** During the performance of this contract, the CONTRACTOR agrees as follows:

The Contractor will not discriminate against any employee or applicant for employment because of race, creed, color, sex, age, national origin, place of birth, physical handicap, or marital status.

- **2.29 PAYMENT TO CONTRACTORS:** Instructions for invoicing the County for service delivered to the County are specified in the contract document.
  - A. Questions regarding payment may be directed to Finance Department at (912) 652-7900 or the County's Project Manager as specified in the contract documents.
  - B. Contractors will be paid the agreed upon compensation upon satisfactory progress or completion of the work as more fully described in the contract document.
  - C. Upon completion of the work, the Contractor will provide the County or contractor with an affidavit certifying all suppliers, persons or businesses employed by the Contractor for the work performed for the County have been paid in full.
  - D. Chatham County is a tax exempt entity. Every contractor, vendor, business or person under contract with Chatham County is required by Georgia law to pay State sales or use taxes for products purchased in Georgia or transported into Georgia and sold to Chatham County by contract. #### SECTION III SPECIAL CONDITIONS

- **3.1 DESCRIPTION AND OBJECTIVES:** In accordance with State of Georgia law, Chatham County is requesting proposals from certified public accounting firms duly licensed to practice within the State of Georgia and qualified to audit its financial statements for the fiscal year ending June 30, 2014. The audit will be performed in accordance with the provisions contained in this request for proposal.
- **3.2 METHODOLOGY:** The procurement described herein is being conducted as a Request for Proposals through professional services selection, a method of selecting professional services as provided in <u>The Chatham County Purchasing Ordinance and Procedures</u> <u>Manual</u>.
- **3.3 PRE-PROPOSAL CONFERENCE:** A pre-proposal conference will be conducted at **10:00 A.M., April 1, 2014**, in the 3<sup>rd</sup> floor conference room of the **CHATHAM COUNTY ADMINISTRATIVE/LEGISLATIVE COURTHOUSE, 124 BULL STREET, SAVANNAH GEORGIA, 31401**, to discuss specifications and/or any misunderstandings that may arise. Representatives from Chatham County will be in attendance. Firms are encouraged to attend.
- **3.4 PROPOSAL DEADLINE:** The response to the Request for Proposals must be received by the Chatham County Purchasing Division no later than <u>5:00 P.M. April 15, 2014.</u> Any proposal received after the time stipulated will be rejected.

Proposals must be responsive to the General Conditions (Information and Instructions), Special Conditions, Technical Specifications, and any attachments.

The County may, for good and sufficient reason, extend the response deadline, in which case all potential proponents will receive an addendum setting forth the new date and time.

- **3.5 WITHDRAWAL OF PROPOSAL:** Your proposal may be withdrawn by written request received by Purchasing before the time fixed for receipt of proposals. Withdrawal of your proposal will not prejudice the right of the proponent to submit a new proposal, providing the latter is received timely as provided herein.

#### 3.8 PROPOSALS SHOULD INCLUDE:

- 3.8.1 **EXECUTIVE SUMMARY (SECTION A):** The Executive Summary of the Proposal shall be limited to three (3) single-spaced typewritten pages. The purpose of the Executive Summary is to provide a high-level description of the offer's ability to meet the requirements of the RFP.
- 3.8.2 **BUSINESS PROFILE (SECTION B):** In this section, proponents will describe their business organization, who will serve as major participants and their respective roles.
  - A. <u>Business Organization:</u> State the full name, address and telephone number

of the proposing firm/organization(s).

- 1. Indicate whether those in the proposing group will operate as a sole proprietorship, individual, partnership, or corporation, and the state of its incorporation or license to operate.
- 2. As applicable, provide the name of the branch office or other subordinate element that will service or assist in servicing the services described herein.
- B. <u>Project Management Team</u>: Identify who will serve as the County's contract representative and the name, address and phone number for whom all contract related correspondence shall be forwarded. successful implementation of the contract, and any other information not specifically required elsewhere in this RFP but considered pertinent by the offeror.

#### SECTION IV EVALUATION

  - 4.3.4 Proponent or Firm must demonstrate its ability to provide the services requested and ability to immediately commence services within 10 days of contract award or at a later date, to be determined by the Finance Director.
  - 4.3.5 Proponent must provide a minimum of three (3) Georgia counties and/or municipalities references for whom the proposer has provided service to in the past five (5) years.
  - 4.3.6 Proponent must demonstrate how workloads will be supervised and monitored for quality during the duration of the contract, and should also specify training in governmental accounting standards provided to staff.

#### SECTION V TECHNICAL SPECIFICATIONS

#### 5.1 DESCRIPTION OF THE GOVERNMENT

- 5.1.1 REPORTING ENTITY The reporting entity for the County, as defined by GASB Statement No. 34, includes all major and non-major funds reported in the Basic Financial Statements for the fiscal year ended June 30, 2013. The County's CAFR can be found on its website at *www.chathamcounty.org.* The report provides additional information on the County's fund structure, accounting and budgeting policies. The County is not included in any other governmental "reporting entity" as defined by Statement No. 34. The County has one (1) blended component unit, the Chatham Area Transit Authority (CAT). The CAT is separately audited and reported as part of County operations as an Enterprise Fund. The County has two (2) discretely presented component units, the Chatham County Board of Health and the Live Oak Library System which are reported separately on the Statement of Net Assets and the Statement of Activities. Financial audits of the County's discretely presented component units are not part of the scope of this request-for-proposal. The Chatham County Tax Commissioners Office is audited by another CPA firm.
- 5.1.2 **NAMES OF CONTACT PERSONS -** The auditor's principal contacts with Chatham County will be Amy J. Davis, Finance Director and Alisa Fish, Assistant Finance Director, who will coordinate the assistance to be provided by the County to the auditor.
- 5.1.3 **BACKGROUND -** Chatham County serves an area of 455 square miles with a population of more than 250,000 and has a total payroll of approximately \$65 million covering about 1,600 employees. The total adopted budget for FY 13/14 is just over \$513 million. The County provides a full range of services, including general government, public safety, health and social services, judicial functions, planning and zoning, parking, sanitation services, water and sewer services, recreational activities, cultural events, general administrative services, and the construction and maintenance of highways, streets and infrastructure. The accounting and financial reporting functions of the County are centralized.
- 5.1.4 **FUND STRUCTURE -** Chatham County uses the following fund types in its financial reporting:

Fund Type/Account Group Number of Individual Funds General Fund 1 Special Revenue Funds 11 Debt Service Fund 1 Capital Projects Funds 8 Enterprise Funds 4 Internal Service Funds 4 Agency Funds 7 Trust Funds 2

The County anticipates establishment of an additional capital projects fund in late 2014 related to a special purpose local option sales tax referendum.

5.1.5 **BUDGETARY BASIS OF ACCOUNTING -** Chatham County prepares its budgets on a basis consistent with generally accepted accounting principles.

- 5.1.6 **FEDERAL AND STATE FINANCIAL ASSISTANCE -** During the fiscal year to be audited, Chatham County anticipates financial assistance by various Federal and State grants.
- 5.1.7 **TRUST FUNDS** Chatham County's Pension Board provides a single-employer defined benefit pension plan for its employees and former employees now employed with the Savannah-Chatham Metropolitan Police Department. The County also has an OPEB trust fund to facilitate pre-funding of other-post retirement benefits.
- 5.1.8 **COMPUTER SYSTEM & OTHER TECHNICAL DATA -** The County's financial computer system consists of two Dell Servers of the same model (Dell PowerEdge R510) which operate with a Microsoft Windows network. Financial application software is provided by SunGard Pentamation, Incorporated. Applications in use include, but are not limited to fund accounting, purchasing, human resources, budget preparation, fixed assets, and cash receipts. In the past, account numbers and balances have been extracted from the system though a COGNOS report writer, then downloaded into Excel. The County also has a report writer program, CAFR 2000, with which also financial statements are produced parallel to the auditor's statements
- 5.1.9 **INTERNAL AUDITOR -** The County's internal audit function is the responsibility of the Internal Audit Department. Internal audit is an independent appraisal function that examines and evaluates the activities of the County's various departments, agencies, and officials. The Internal Audit Director reports to the County Manager.
- **5.2 SCOPE OF SERVICES:** The Successful Proponent hereafter referred to as "Service Provider", will be responsible for providing the following services:
  - 5.2.1 Chatham County desires the Proponent to express an opinion on the fair presentation of its basic financial statements in accordance with generally accepted auditing standards.
  - 5.2.2 The Proponent shall audit the financial statements consisting of the governmental activities, business-type activities, aggregate discretely presented component units, each major fund, and the aggregate remaining fund information for all fund types.
  - 5.2.3 The Proponent shall also issue a report on the County's internal controls over financial reporting and test compliance with certain laws, regulations, contracts and grant agreements matter.
  - 5.2.4 The Proponent shall provide an "in-relation-to" report on the supporting schedules and required supplementary information based on the auditing procedures applied during the audit of the general purpose financial statements.
  - 5.2.5 The Proponent is not required to audit or express an opinion on the statistical section of the report or Management's Discussion and Analysis, but should review it. Furthermore, the Proponent shall provide an "in-relation-to" report on the schedule of federal and state financial assistance and other state-mandated schedules based on the auditing procedures applied during the audit of the financial statements.
  - 5.2.6 The audit shall be performed in accordance with generally accepted auditing standards, federal and state laws including but not limited to: auditing standards generally accepted in the United States, procedures recommended by the American Institute of Certified Public Accountants, the standards for financial audits set forth by the Comptroller General of the

United States in *Government Auditing Standards*, the provisions of U.S. Office of Management and Budget (OMB) Circular A-133, *Audits of State, Local Governments and Non-Profit Organizations*, and the laws of the State of Georgia.

- 5.2.7 Following the completion of the audit of the fiscal year's financial statements, the Proponent shall issue the following reports, based on current standards:
  - A. A report expressing an opinion of the presentation of the financial statements in conformity with generally accepted accounting principles.
  - B. A report on internal controls over financial reporting.
  - C. A report on compliance with applicable laws, regulations, contracts, grant agreements and other matters.
  - D. An "in-relation-to" report on the schedule of expenditures of federal awards.
  - E. A report on compliance with laws and regulations applicable to each major program and on internal control over compliance in accordance with OMB Circular A-133.
  - F. Schedule of Findings and Questioned Costs and Status of Prior Year Major Federal Award Programs Audit Findings including listing of significant deficiencies and material weaknesses.
  - G. Any reports as required by state law, such as reports related to state-mandated program
    I information, grant certifications, and solid waste financial assurance.
  - H. A Management Letter wherein items not listed as a significant deficiency or a material weakness are communicated to management.
  - I. Any other reports mandated by changes in the auditing and compliance environment.
- 5.2.8 The Auditor will prepare the financial statements. The Finance Department intends to run financial statements that parallel statements prepared by the auditing firm.
- 5.2.9 Other special considerations of note to the Proponent include:
  - A. Chatham County will send its comprehensive annual financial report to the Government Finance Officers Association of the United States and Canada for review in its Certificate of Achievement for Excellence in Financial Reporting program. It is anticipated that the Proponent shall be required to provide assistance to Chatham County to meet the requirements of that program. Chatham County has received the Certificate of achievement for the last 29 consecutive years.
  - B. The Schedule of Expenditures of federal awards, related reports and schedules, as well as reports on the internal control structure and compliance, shall be issued separately from the comprehensive annual financial report.
  - C. Chatham County will require the Proponent's overall evaluation of the efficiency and adequacy of accounting procedures.
  - D. The Proponent shall be requested to grant permission to use the Auditor's Opinion in the Official Statement of any future bond issues. In addition, the Proponent shall be required, if requested by the County, fiscal advisor and/or underwriter, to issue a "consent and citation of expertise" as the auditor and any necessary "comfort letters".

- E. As requested by the County, the Proponent shall assist or provide advice in the implementation of any new required Governmental Accounting Standards Board statements, auditing standards, and/or technical bulletins. Independence will be considered.
- F. The Proponent shall prepare the data collection form at the completion of the audit.
- G. Subsequent to its publication, the County may choose to post the CAFR on the County's web site.
- H. All working papers and reports must be retained, at the Proponent's expense, for a minimum of five (5) years as specified under S.A.S. 103, unless the firm is notified in writing by Chatham County of the need to extend the retention period. The Proponent shall be required to make working papers available, upon request, to Chatham County, auditors of entities of which Chatham County is a sub recipient of grant funds and other federal or state agencies as necessary. In addition, the Proponent shall respond to the reasonable inquiries of successor auditors and allow successor auditors to review working papers relating to matters of continuing accounting significance.
- **5.3 BACKGROUND AND OBJECTIVES IN TECHNICAL PROPOSAL** The Technical Proposal should describe the qualifications, competence and capacity of the firm seeking to provide auditing services to Chatham County in conformity with the requirements of this request for proposals. Many of the guidelines for the technical proposal are already listed in Sections 4.3.

The respondent should also respond to the following items:

5.3.1. **GENERAL REQUIREMENTS** - The technical proposal should demonstrate the qualifications of the firm and of the particular staff to be assigned to this engagement. The technical proposal should address all the points outlined in the request for proposals. The proposal should be prepared simply and economically, providing a straightforward, concise description of the proposer's capabilities to satisfy the requirements of the request for proposals.

5.3.2 **FIRM QUALIFICATIONS AND EXPERIENCE** - As stated in Section 3.8, the proposal should provide information on firm qualifications and experience. In addition, the proponent should submit a copy of the report of its most recent external quality control review, with a statement whether that quality control review included a review of specific government engagements.

The firm shall also provide information on the results of any federal or state desk reviews or field reviews of its audits during the past three (3) years. In addition, the firm shall provide information on the circumstances and status of any disciplinary action taken or pending against the firm during the past three (3) years with state regulatory bodies or professional organizations.

Please include the responses pertaining to external quality control review and state desk review in an appendix.

#### 5.4 PRELIMINARY SCHEDULE FOR FY 2014 AUDIT

- 5.4.1. **May 2014** Entrance conference with Finance Director and key staff to discuss interim and year-end work to be performed. The County annually has a planning meeting to discuss the fiscal year closing process and to identify any issues that may impact the timing of the closing. The Auditor is expected to participate in this meeting to discuss any mandated or proposed reporting changes that would apply to the current year and the subsequent fiscal year as well as to agree to a proposed time line.
- 5.4.2 May and June 2014 Preliminary audit work.
- 5.4.3 August 2014 Fieldwork begins. Preliminary trial balance is provided.

- 5.4.4 **September 2014** Fieldwork is completed. Results of preliminary review and potential adjustments to the trail balance are communicated.
- 5.4.5 **October 2014** CAFR draft is completed and submitted to auditor for review.
- 5.4.6 **November 2014 -** Exit conference with Finance Director and County Manager to summarize results and review significant findings.
- 5.4.7 **December 2014** Presentation to Commission covering significant matters of the financial operations and on any material findings reported in the management letter.

In addition, the Auditor will provide, at a minimum, monthly progress reports throughout the audit process outlining the progress to date and any accounting or auditing concerns which would have come to the auditor's attention and would have an impact on any items included in this scope of services.

#### 5.5 ASSISTANCE TO BE PROVIDED TO THE AUDIT FIRM AND REPORT PREPARATION

- 5.5.1 The Proponent shall provide Chatham County with a list of schedules to be prepared by County staff.
- 5.5.2 The Proponent will be given free access to records of the County and reasonable access to the staff for the purposes of interviews and follow-up.
- 5.5.3 The Proponent shall maintain such records as privileged and confidential information. It is expected that the Auditor will organize the work in such a way as to minimize disruption of work of County employees in the pursuit of their normal duties.
- 5.5.4 The preparation of confirmations will be the responsibility of Chatham County.
- 5.5.5 Chatham County will provide the Proponent with reasonable workspace, desks and chairs. The Proponent will also be provided with access to local telephone lines, photocopying facilities and computer.
- **5.6 FEE SCHEDULE -** A fee proposal shall be submitted as preferred in Section VI. The total all-inclusive maximum price to be proposed is to contain all direct and indirect costs including all out-of-pocket expenses. The County will not be responsible for expenses incurred in preparing and submitting the technical proposal or the sealed dollar cost proposal. Such costs should not be included in the proposal:
