- D. PROVIDE HOLD-DOWN CLIPS AT ACOUSTICAL CEILINGS AT ALL ROOMS IN INMATE AREAS, AND AT ALL VESTIBULES.
- E. SPACES NOT LISTED ON THIS SCHEDULE TO KEEP EXISTING FINISHES, AS IS.
- F. IN ROOMS WITH MORE THAN ONE DOOR WHERE SIGNAGE IS PROVIDED, PROVIDE SIGNAGE AT EACH DOOR.
- G. PATCH AND REPAIR AS REQUIRED TO RECEIVE FINAL FINISHES PER SPECIFICATION AND / OR MANUFACTURER'S REQUIREMENTS.
