 - a. Please mention scope of supply in electrical part.
 - b. Is it 10HP rating of FVNR for Pump motor?
 - c. Do they need FVNR starter only? Or also looking for VFD? No information of VFD in document.
 - d. What is SCADA Radio? What is functionality of it?
 - e. What are the requirements of a Nema 4X junction boxes? Mention with size. Related document "Spec. 260000. paragraph. 2.08" is missing.
 - f. Require detail of oz Gedney EYA with function?
 - g. Which kind of ground fault detection sensing is required?
 - h. Is weatherproof area light and its work a separate item of electric panel?
 - i. Require the detail of Bypass pump system with operating sequence.
 - j. Which type of protection is required?
 - k. If any process sequence is required, then mention in detail.

Response:

- a. The scope of the electrical work is inclusive of the specifications and drawings.
- b. The FVNR starter shall be a NEMA size 1.
- c. No VFD is required for this project.
- d. The SCADA radio is an Omni-Site XR50 Cellular Alarm Dialer, it will report alarm conditions to the owner.
- e. The required junction box is a Hammond Manufacturing EJ12126SS 12"x12"x6" Junior Eclipse Series with aluminum backplate.
- f. Refer to the OZ Gedney catalog, this is a gas-tight seal-off fitting.
- g. Provide Ground Fault protection only in the duplex receptacles.
- h. It is part of the electrical scope of work for the project.
- i. Refer to the Civil drawings and specifications.
- j. NEMA 4X stainless steel
- k. Refer to the project specifications.

2. Addition:

The following specification will be added:

a. Contractor shall only work during daylight hours between 7:30 AM to 6:30 PM.

3. <u>Clarification:</u>

- a. The Temporary Bypass Pump System shall include two temporary bypass pumps and a backup pump that remains on-site. The temporary bypass system shall include a total of three bypass pumps.
- b. Section 33 31 14 Section 2.01 D states "all discharge systems shall be temporarily constructed of rigid High Density Polyethylene (HDPE) with positive restrained joints." It has been confirmed this shall remain as stated.
