FLOORING RENOVATIONS AT THE CHATHAM COUNTY ANIMAL SERVICES


PLEASE SEE THE FOLLOWING FOR QUESTIONS AND ANSWERS:

- In the documents you have listed extended warranty, what is the length of warranty that you are looking for and is it material, or material and labor? **Section 3.2 Warranty Requirements indicates the standard warranty shall be offered with bid which is (1) one year all material and labor. However, there is a line on the bid sheet for a (5) five year extended warranty for all materials and labor as an option.**
- Can BASF MasterTop floor epoxy system be considered as an equal alternative? **No.**
- What are the work hours and days allowed during the process? **Daily 8AM -5PM, 7 days a week.**
- Will there be continuous work from one phase to another or will there be a period of time between phases? **We need to use the space completed before we can move to the next phase so it would depend on how long it takes for each area to cure.**
- Do we know what the floor is coated with now? **No. It appears to be paint.**
- What is the approximate start date and days to complete? **A Contractor can start 10 days after receiving the "Notice to Proceed" letter. Contractor has 30 days to complete project.**
- Is there a drawing of the kennel areas that can be scanned and emailed out? **No.**
- Is there an area that a small storage trailer may be parked to store equipment and materials in? **Yes there can be an area for a small trailer.**
- It was noticed that in Kennel #1 there were some spalls that had previously had repairs made, In the process of removing current floor coating there could be the possibility of delamination of repair materials. Will Chatham County have an engineer on staff to survey any repairs and will there be a unit price repair for those areas? **No.**
