PLEASE SEE THE FOLLOWING ADDITIONS, CLARIFICATIONS AND/OR CHANGES:

1. **Question:** When is the Contract start date?

Response: Upon Board approval a contract will be executed. The start date is

projected to be May/June 2018.

2. **Question:** When is the Contract end date?

Response: As stated in Section 3.6 of the bid document, this solicitation will

result in an "Annual Contract with renewal options for four

additional one year terms if all parties agree.

3. **Question:** What are the payment terms?

Response: The County's payment terms are net 30 days and payment is made

in the form of a check. Chatham County does not pay late fees.

4. **Question:** Can the County provide the addresses and tank sizes of all the

locations listed in the Bid?

Response: The County has three sites. Site 1 is Chatham County Fuel Station,

7240 Varnedoe Drive, Savannah Georgia. It has two tanks, 20,000 gallon bio diesel, and 15,000 gallon unleaded gasoline. Site 2 is Sheriff's Complex, 1050 Carl Griffin Drive, Savannah, Georgia. It has two 10,000 gallon unleaded gasoline tanks. Site 3 is Mosquito Control, 65 Billy B. Hair Drive, Garden City, Georgia. It has two tanks, one 4,000 gallon bio diesel and the other is 4,000 gallon

unleaded gasoline.

The City of Savannah has three sites. Site 1 is 201 Habersham Street. It has one 10,000 gallon tank – gasoline only. Site 2 is 1100 West Gwinnett Street. It has two 10,000 gallon tanksgasoline, and two 10,000 gallon tanks—bio diesel. Site 3 is 6900 Sallie Mood Drive. It has two 10,000 gallon tank and two 10,000 gallon bio diesel.

City of Tybee has two tanks, 2,000 gallon bio diesel and 8,000 gallon gasoline.

Board of Education has four tanks. One 12,000 gallon gasoline and three 12,000 gallon bio diesel.

City of Bloomingdale has two tanks. One 4,000 gallon gasoline and one 2,000 gallon bio diesel.

5. **Question:** Can you please specify which locations get unleaded regular,

unleaded premium, mixed unleaded?

Response: The County and the other agencies except City of Bloomingdale

require E10P Regular Ethanol Gas 87. City of Bloomingdale

requires Premium Unleaded.

6. **Question:** What form of bio diesel would you like to receive?

Response: The County and the other agencies except City of Bloomingdale

require Ultra Low Sulfar Diesel Clear. The City of Bloomingdale

requires Low Sulfar Diesel.

7.	Question: Response:	By 50/50 mix does this mean midgrade gasoline? 50/50 mix is no longer a requirement and has been removed on the revised bid sheet. The City of Tybee requires the same gasoline as Chatham County. See Response to Question 5.
8.	Question: Response:	Is the contract for Diesel or Bio Diesel? The contract is for Bio Diesel. Any reference to diesel in the bid document should be changed to bio diesel.
