 <u>RESPONSE:</u> CCERP meeting minutes are now posted along with the RFP documents on the County's website at purchasing.chathamcounty.org.
- 7. **<u>OUESTION:</u>** For M/WBE participation, does Chatham County have a target percentage goal or dollar goal they can share.

RESPONSE: The County does not have a target percentage goal or dollar goal.
