- 3. **QUESTION:** Equipment list Courtroom 1 Item 1 Specified size is different than that shown on drawings. Please clarify. **RESPONSE:** The equipment has been replaced with a new model number ViewSonic CDE6520 65" 4K Premium Commercial Display Native Resolution: 3840 x 2160 as listed on the revised bid sheet.
- 4. **QUESTION:** Equipment list Courtroom 1 Item 3, Qty is different from drawings. Please clarify.
 - **RESPONSE:** Refer to drawings. The County will not be using the Crestron Digital Media 8G+® 4K60 4:4:4 HDR Receiver and Room Controller.
- 5. **QUESTION:** Equipment list Courtroom 1 Item 5 Items are not shown in the project drawings Are they required? **RESPONSE:** Refer to the drawing. The County will not be using the Crestron Digital Media 8G+® Transmitter 201.
- 6. **QUESTION:** Equipment list Courtroom 1 Items 6-9. How do you plan to connect to the interfaces? Are retractors, permanent connection cables required? **RESPONSE:** Refer to the drawing. Per the revised bid sheet the County will be using the Video Input Transmitter Crestron HD-MD-400-C-E utilizing the Liberty Ring part numbers as follows: FT2-700-B, FT2A-PLT-KEY-10, US Single (Type-B), HDMI Retractor, USB-C/A Charging, Blank Plates (20) and the VGA Retractor.

- 68. **QUESTION:** Drawing AV-07 shows a Biamp EX-LOGIC expander but this part is not on the Bid Sheet. What is the process for adding a line item that is missing? **RESPONSE:** Refer to drawing AV-07. Use Biamp Expander EX-Logic per the revised bid sheet.
- 69. **QUESTION:** Drawing AV-07 shows a Cisco SG-300-28PP but this part is not on the Bid Sheet. What is the process for adding a line item that is missing? **RESPONSE:** Refer to drawing AV-07. Use Cisco SG300-28PP Network Switch per the revised bid sheet.

Please clarify the complete system and parts required and provide a line drawing for the Sound masking system.

- 75. **QUESTION:** Drawing AV-08 shows Extron USB Media Bridge but this part is not on the Bid Sheet. Please advise. **RESPONSE:** Refer to drawing AV-08. Use Extron USB Media Bridge per the revised bid sheet.
- 76. **QUESTION:** Drawing AV-08 shows Extron 60-1437-01 Distribution Amplifier (Qty. 1) but this is not on the Bid sheet. Please advise. **RESPONSE:** Refer to drawing AV-08. Use the Extron 60-1437-01 Distribution Amplifier per the revised bid sheet.

- 78. **QUESTION:** Drawing AV-08 shows Crestron DM-RMC-4KZ-100-C (Qty. 1) but Bid sheet has Qty. 5. Please specify correct # or revise drawing to show placement of the additional units. **RESPONSE:** Refer to drawing AV-08. Use the Crestron DM-RMC-4KZ-100-C per the revised bid sheet.
- 79. **QUESTION:** Drawing AV-08 shows 75" Samsung QM75N but bid sheet specifies 86" Viewsonic CDE8600. Please clarify proper size and desired model. **RESPONSE:** Refer to drawing AV-08 for placement and use of the new model number ViewSonic CDE7520 75" 4K Premium Commercial Display per the revised bid sheet.

80. **QUESTION:** Bid sheet (line 45) refers to a part (Chief TS325TU...qty. 4) that is not compatible with anything specified for this Courtroom. Please clarify or remove from Bid sheet.

RESPONSE: Line item 45 will no longer be used. Please see the revised bid sheet.

- 81. **QUESTION:** Drawing AV-08 shows two (2) Vaddio camera systems. One is shown as a RoboShot 12 (front wall) and the other is a RoboShot 30 (back wall). The Bid sheet has two (2) RoboShot 12 systems. Please clarify if this should be one (1) RoboShot 12 and one (1) RoboShot 30 as shown on the drawings and update the Bid Sheet accordingly. **RESPONSE:** Refer to the drawing AV-08. Use a Roboshot 12 (front wall) and the Roboshot 30 (back wall) per the revised bid sheet.
- 82. **QUESTION:** Line 61 of the Bid Sheet specifies a Vaddio AV Bridge but this part is not reflected on the line drawings. Please clarify. **RESPONSE:** Refer to the drawing. Line item 61 will no longer be used. Please see the revised bid sheet.
- 83. **QUESTION:** Drawing AV-09 shows Shure MV395B/O-LED (Qty. 2) but these are not shown on the Bid sheet. What is the process for adding a line item that is missing? Also, please confirm the part # since there is a discrepancy on this same item in Courtrooms 1 & 3.

- 85. **QUESTION:** Drawing AV-10 shows a Biamp EX-LOGIC expander but this part is not on the Bid Sheet. What is the process for adding a line item that is missing? **RESPONSE:** Refer to the drawing AV-10. Use EX-LOGIC expander per the revised bid sheet.
- 86. **QUESTION:** Drawings AV-11, AV-12 an AV-13 reference Cambridge Sound Management QT-100/QT-300/QT600 sound masking systems but there are no line drawings for the Sound masking system other than emitter speaker quantities.
