4.2 BUILDING SPECIFICATIONS:

- 4.2.1 Construct and install a 40 x 40 x 12 Training building #4 using 40 year painted metal. To include 1 set of double steel doors, a single steel door and two 3 x 5 windows.
- 4.2.2 Construct and install a 30 x 32 x 14 breezeway using cold form steel and 40 year painted metal.
- 4.2.3 Construct and install a 60 x 120 x 16 metal building that will be enclosed on three sides, using 40 year painted metal. Also to include 3 steel doors.
- 4.2.4 Chatham County will handle all electrical work.

4.3 CONTRACT SPECIFICATIONS:
