Not approved. Tufting gauge specified (1/2-inch) is not equal to approved synthetic turf systems and pea gravel does not meet sand gradation requirements in Section 321813 Part 2.3.C.3.
RFC 26	1/14/2021	In the turf specification Section 321813 Page 8 of 11 under C.1. it states that all products shall use virgin EPDM rubber and sand. Please confirm the owner is requiring every bidder to include virgin EPDM rubber in their bid as opposed to SBR as there is a significant cost increase to go from SBR to EPDM.	Virgin EPDM rubber and sand is not required. Section 321813 Part 2.3.C.1 shall be modified to read as follows: "1. Infill shall be per manufacturer specifications and may consist of mixtures of graded dust-free, rounded silica sand and SBR rubber crumb, layered cryo rubber, or virgin EPDM rubber."

Dugout roof framing is not required to be pre-engineered and may be framed in the field out of wood or 3" diamater steel piping to match the dugout fence framing. Metal roof panels shall match concession building roof and may be fastened directly to roof frame.
